# Chairman's Letter

It is already spring of 2017 and welcome to the latest edition of Oranges & Lemons! A year ago I reported that we had, in the previous November, hosted our best ever Annual Concert. I also set the challenge: to take the event in November 2016 (with all players well established) to an even higher level, to appeal to an even wider audience. Everyone rose to that challenge and through a huge team effort the concert really was a massive success. More

people attended than ever before, we raised more money to assist in our work and most importantly we were able to give back to all who support the Friends, many of whom told me that "it just keeps getting better". Thank you to everyone who assisted in making the evening so special and thank you for attending.

We also held our AGM on the afternoon of the concert and I was able to report an increase in membership numbers through the links to RAF Stations and through wider publicity. The rate of increase is still too slow, but we will work on that further this year. I also reported that over the course of 2016, 75% of our income was turned into grants (the majority of the remainder remaining in our funds!), but that we also need to fundraise if we are to tackle larger cost items for the church. All agreed to support us in the raising of funds for the vital work we do.

We also welcomed a new member to our Board of Trustees: Squadron Leader Lorna Hoban, who has agreed to take on the role of Membership Secretary. Lorna is serving in the Ministry of Defence and is keen to continue the good work of encouraging more serving personnel to join the Friends. Wg Cdr Chris Hill (known affectionately as 'CJ') stepped down from this role. However, he remains with us on the Board where I intend to use his Friends knowledge! Thank you CJ for all you have done as only the second Membership Secretary we have had since the formation of the Friends!

Finally, may I thank you all for your support at the concert and throughout the year. I hope that your 2017 is prosperous and I am sure the Friends work will be too.

# Strange but True

**Chris Hill, the outgoing Membership Secretary** 



By mid-1994 it had come to the then Chaplain in Chief's attention that the Chairman of the Friends, Air Commandant Dame Felicity Peake, had proposed the purchase of a computer. Being concerned at the proposed expenditure he contacted my Director at the Directorate of Communications and Information Systems to seek agreement for me to attend the next meeting of the Friends. My task was to professionally enquire 'what the computer was to be used for, and who was going to use it'.

Duly armed I not only attended the next meeting but was remitted to attend future meetings to ensure that if a computer was needed it was properly specified, particularly as most software was specialised two decades ago.

In 1995 came the sad news to the Friends that the then Membership Secretary, Alan Dockerill, had died. With the committee being small, and as the only member without a specific role, I became your Membership Secretary! Whilst I didn't acquire the 'quill pen' with the original Membership Secretary's records, I did acquire all the original ledgers and paper records. At this time all members' records ran from the date on which they joined, so the Membership Secretary sent annual reminders rather regularly and by snail-mail.

I had to improve things and firstly created a digital version of the original Friends headed paper and started the process of writing

standard renewal letters, firstly for single membership, then joint membership and then for annual renewals. A year later it was agreed that we should standardise the membership year as 1 July to 30 June. Fortunately this did not affect our life members, and we still have a couple of members who pay their annual membership by Standing Order and their dates have not changed.

Next, a whole raft of initiates were embarked upon when we realised that we were not taking advantage of the Gift Aid opportunities available to charities. A rewrite of our Constitution was required and submitted to the Charity Commission for Registration on 21 August 1995, and soon afterwards we registered with HMRC for Gift Aid. Our next piece of work was linked to the production of Oranges & Lemons and gaining HMRC agreement that the magazine provided a business content e.g.: 'Notice of the AGM', 'AGM Agenda', 'AGM Minutes' or other business information in it. It would therefore not be classed as a member's benefit which might compromise our Gift Aid claim status.

In early 2000 we realised that we were not meeting the correct proportional representation at the AGM that our constitution required. After some tortuous interaction with the Charity Commission, a Special Resolution was agreed and voted on at an Extraordinary General Meeting, on 15 May 2005, where we changed the AGM attendance requirement. All is therefore in place and I have enjoyed being able to support the Friends over the past 21 years. I am truly delighted that our current Chairman has found a serving volunteer to take over the Membership Secretary role and who is also based in London; so a very warm welcome to Squadron Leader Lorna Hoban, from what I believe is, the second Membership Secretary to the third! Good luck for the future.

Oh, and by the way, the Friends still haven't found a need to buy a computer yet!

# 1. Prayer

The Resident Chaplain opened the AGM with a prayer.

# 2. Apologies

Apologies were noted.

# 3. Chairman's Opening Remarks

The Chairman reported that the focus of the Friends Trustees this year has been on increasing membership numbers by reaching out to serving RAF personnel. To this end a network of representatives across all RAF Stations and Units has been established to raise the profile of the Friends and a schedule of subscription fees proposed for AGM approval, based on rank, to ensure membership is affordable. Membership numbers are increasing.

The relationship between the Friends and the main St Clement Danes Trust is strong. The Trust Chairman and Chaplain in Chief will both be attending this evening's Friends Annual Concert. An update on the activities of the Friends remains a standing agenda item at meetings of the main church Trust on which The Chairman of the Friends sits. Similarly, support from the RAF for the Friends is firm, including from the Chief of Air Staff as Patron.

Regrettably, owing to illness, Mr Roger Round, a current Trustee of the Friends, has had to step down from his role as Trustee. Thanks for his service will be offered at the appropriate time.

The Friends has been active in making grants to the church this year. Grants totalling £13,540 were made during the last financial year for items including: filing cabinets for music scores; an 'A-frame' to enable the grand piano to be moved around the church safely; a burse and veil for communion services; robes for the Director of Music and personal panic alarms for staff in the church.

Finally, the Chairman informed the meeting that the Band of the RAF Regiment would be performing in today's Friends Annual Concert alongside Simon Over, the new Director of Music, and the church choir. Following on from the success of last year's concert a brand new musical programme had been put together, for which it would be well worth attending.

# 4. Election of Officers and Trustees

# 5. Minutes of Last Meeting

The minutes of the last AGM had been made available via the Spring 2016 edition of O&L magazine and the Chairman asked if there were any questions. There being none, approval was proposed by Wg Cdr Chris Hill, seconded by Mr Peter Neville-Lewis and passed unanimously on a show of hands.

# 6. Treasurer's Report

Copies of the Receipts and Payments Account for the year to 30 June 2016 were distributed (see Appendix I).

The Treasurer detailed the various sources of cash inflows and outflows. Grants made in the year represented 75% of receipts. O&L publishing and distribution costs represented 20% of payments and administrative expenses 10%. Last year's Friends Annual Concert generated a profit of £70.

The 'Restricted Funds' column in the accounts relates to a donation made specifically to promote music at St Clement Danes. At the end of the accounting year to 30 June 2016, £1,500 of the original donation was available to carry forward.

In response to a question on the profitability of the Friends Annual Concert and where expenditure on the event is incurred, the Treasurer indicated that Concert costs included: refreshments, band meals, Director of Music and choir fees. The RAF Regiment Band provided their services for free as a donation to the Friends. Although not a money-spinner it was thought that the Concert generated much goodwill amongst Friends and was a key event in the Friends diary. For many Friends it marked the beginning of the Christmas season.

Approval of the accounts was proposed by Wg Cdr Di Bentley, seconded by Gp Capt Peter Holtby and passed unanimously on a show of hands. Given the scale of Friends Receipts and Payments,

an independent audit was not required by the Charity Commission and not recommended by the Trustees, given costs involved.

# 7. Membership Secretary's Report

The Treasurer reported that as at 1 January 2016 membership numbers stood at 695 and 686 as of today's date. 16 new members joined the Friends, one life member was reinstated. 12 members passed away since the start of the year, 3 had 'gone away' and 11 had cancelled their subscription. Currently there are 406 life members, 3 honorary members, 4 corporate members and 273 paying annually. Of the latter category, 226 pay by direct debit, 22 by standing order and 29 by cash/cheque (including 4 overseas members).

The Membership Secretary explained that, as previously resolved in the AGM, subscription rates are reviewed every two years. Copies of the new Subscription Fee Schedule, as recommended by Trustees, were therefore distributed (see Appendix II).

Approval of the Schedule was proposed by Wg Cdr Chris Hill, seconded by Wg Cdr Di Bentley and passed unanimously on a show of hands.

The Chairman informed the AGM that the current Membership Secretary, Wg Cdr Chris Hill, would be stepping down from his role this meeting, to be replaced by Sqn Ldr Lorna Hoban. He would remain a Trustee of the Friends. He would also be able to assist the church through his role as Master of St Clement Danes Freemasons Lodge.

The Chairman thanked Wg Cdr Hill for his 21 years of service to the Friends as Membership Secretary, pointing out that he was only the second Membership Secretary in the long history of the Friends!

# 8. Any Other Business

The Chairman reported that repairs to the church bell tower were likely to take place shortly. The matter would be discussed tomorrow in a scheduled meeting of the Trustees of the main church Trust.

The two lavatories inside the church would be available for attendees of this evening's Annual Friends Concert to use.

Mrs Youle was delighted to see Padre Thomas, the principal individual responsible for setting up the Friends, featured in the Autumn 2016 edition of Oranges & Lemons Magazine.

# A POW Air Gunner (Part 2)

# Albert D Gunn ACA

(from Scottish Saltire Aircrew Association)

After interrogation by the Germans, which included an attempt to get Albert to sign a form giving details about his Squadron and aircraft type (supposedly to obtain Red Cross parcels and with which he refused to comply), he was sent to Stalag IVB Prisoner of War



camp. He continues in his own words.

"It was dark as we approached Stalag IVB and the weather was very cold with slush on the ground. We could see dozens of figures at the wire, all shouting and waving, but could not understand what they were trying to convey to us by their signs. We were soon to find out. We were marched into the de-lousing area which meant stripping completely and all the clothes were put through a chamber where they were exposed to chemicals which killed off unwelcome 'visitors'. We were ordered into a room with shower heads on the ceiling and had to wash thoroughly, which was very welcome, and then into the next room where warm air dried us off. Two Italian POWs were waiting to give us typhus vaccinations, which seemed to us very crude. One scratched your arm with what looked like a pen nib and the other daubed on some paste. I managed to dodge that particular operation which made some men quite ill. The Russian hairdresser you could not miss. He sat with his cutter and we all had our hair removed which, of course, you could not hide. The real horror came when the clothes came from de-lousing and I. like many others, found my flying boots missing, taken by the Germans for soldiers serving on the Russian front. That was what the shouting was all about when we entered the camp. The choice of footwear left to us was wooden soles with a piece of material to put your foot into - useless for the camp conditions.

The Stalag was situated on the east bank of the Elbe near a town called Muhlberg. It was a transit camp for working parties going out to work for the Germans, in theory, on non-military jobs. As aircrew were all sergeants or above we were not allowed to be used in this way. Being billeted with mainly army personnel, many of whom had been POWs for some time, led to quite a lot of friction as discipline in the RAF was much slacker. At morning roll-call, we tended to mess about, always being last to fall-in and often the guards had to go into the huts in search of late sleepers. This, of course, led to the whole parade being kept waiting in the cold for long periods.

For the first six months we had a fairly regular supply of Red Cross parcels, which was really a life saver. Usually, issued on a Monday, we were also allocated 50 cigarettes each and, as Jack was the only smoker in our group, we put 25 cigarettes into a pool to buy extra food and we each had 25 to spend as currency in the camp. Gerry and I usually bought a bar of chocolate which was contained in the Canadian parcels and, when available, a loaf of bread for 50 cigarettes out of the pool to be shared by the three of us.

The bread we tried to buy was smuggled into the camp by various people, mainly French prisoners who went out to work daily in Muhlberg. We also 'bought' from Russians who were employed in the never-ending job of pumping the 'dry' cesspit toilets into a large barrel-shaped container on wheels and pulling it into the countryside and spraying it over the fields as manure. They were known as 'Scheissen Torpedoes' and it was easy to realise that the camp could be located in the dark by the awful odour which surrounded it. We went off dealing with the Russians when we found out that they were smuggling in the bread suspended in the 'Torpedoes'. As all deals were done in the dark, one or two people were caught out by exchanging their cigarettes for a loaf and when they got back to camp, finding the inside had been scooped out and stuffed with a piece of rag leaving only the crust.

Life progressed through 1944 with, of course, the highlight being 'D' Day on the 6 June and our thoughts turned to being home by Christmas. We were kept up-to-date with the news each evening by a radio in the camp for which the Germans were constantly on the search, fortunately without success. The search team was led by a guard nicknamed Alpine Harry as he always carried a climbing axe.

He would choose some unfortunate's bunk and tear it apart in his futile search.



During the summer of 1944 an event took place which caused us some upheaval. A New Zealander, named Ward, had escaped from a camp in Italy and had joined a partisan group in the mountains. He was eventually captured by the Germans who considered him a

criminal and he had been charged with murder. He was due to stand trial at a civil court in Dresden which was about 20 miles from our camp. The bulk of the RAF prisoners were in a compound of eight huts and, on the morning Ward was due to go to Dresden, he was taken to the de-lousing chamber to be freshened up for his journey. The route from the punishment cell to the showers meant crossing the camp main road and as he returned with his guard, dozens of RAF prisoners surrounded him and, eventually, when the main guard was called out and order restored, Ward had disappeared.

One morning, roll-call was called as usual with the normal casual response until, on leaving the hut we found each hut surrounded by SS troops with machine guns covering the whole compound. The black uniforms and aggressive attitudes made us realise that this

was serious and we were instructed to parade with all our belongings ready to move out. We had to go before a group of Gestapo sitting at a table who checked us off against our photographs. We were then told to make our way to the far end of the camp near the main entrance and move into huts vacated by Dutch POWs. All the Germans' efforts were in vain as Ward was not found and, in fact, lived the rest of the time in captivity in the camp."

Albert continued to endure POW camp life with its ups and downs, the 'ups' being receipt of the occasional Red Cross parcel and 22 letters on his 20th birthday, and the 'downs' being discovery of an escape tunnel when it was collapsed by a tractor which fell into it, the need to sleep three in a side-by-side double bunk when 100 Americans were added to the occupancy of each hut and an attack

German guards by Russians. Albert continues his account of what then transpired.

"Despite our hopes of getting home quickly and countless rumours, nothing happened. On the 1 May the Russians put up some decorations to celebrate May Day and proceeded to have a party in the old guard block. Many of us took the opportunity to raid the office block and remove all our records which, in the case of the

RAF men, included photographs. The Russians were most upset and insisted that we all fill in new forms giving personal details. I often wonder what some poor Russian clerk made of it all, as nobody gave their real name or address in the UK as requested. Days went by with food being the prime concern, along with when we would leave the camp. Scrounging became a dangerous game. The Americans were moved out on the 2 May but by 4 May rations were raw potatoes and still no light or water in the camp.

On Sunday 6 May we left Stalag IVB at last at 2.30pm. We crossed to the west bank of the Elbe at Strehla and arrived at Riesa about 7.30 in the evening. We were astonished to be welcomed by the Germans with cold drinks and invitations to their homes, and our group of five peeled off into the home of a lady with a mentally handicapped daughter. The reason for the invitation became only too apparent when we saw how the Russian army of occupation conducted itself. Any woman of any age was fair game for the soldiers and the women had found that having an Allied serviceman in their house meant that a Russian would not enter.

A force of Russians with green bands on their caps moved into town and quickly asserted their authority over everyone. All Allied POWs were rounded up and billeted in an ex-German Panzer unit barracks; unfortunately without any beds and we had to sleep on the floor. Food was still scarce and we set off on the scrounge for provisions. Gerry and I found some allotments where we acquired some vegetables and Gerry used his country skills by obtaining a rabbit from a hutch in one of the gardens. Potatoes were found by some of the others and Jack located a cider factory, to which Cyril and I returned and obtained a jar of cider. The factory had two very large tanks where we assumed the cider was allowed to ferment

and when we arrived two Russian soldiers were sitting by the outlet valves trying to get cider to drink. One of the soldiers got impatient and riddled the tank with his sub-machine gun and we left them with cider pouring out of the tanks up to their knees and happily scooping it up and drinking it. The date was 8 May and we listened to Churchill giving his famous speech before settling down to our celebration dinner.

To say the dinner was unforgettable would be an understatement as I have never been so sick in my life. The rabbit was not cooked enough, the dehydrated potatoes were 'off' and the cider was raw. Whatever the reason, I have never knowingly eaten rabbit again. To make things worse the Russians, who had now put a guard on our billets, celebrated VE Day by firing-off a large quantity of captured ammunition which was lying all over the place. They seemed to take great pleasure in firing at the barracks' windows which, in our miserable state, meant getting to the toilet was difficult."

It was the 23 May before a fleet of American army lorries arrived and transported Albert and his POW colleagues to an airfield at Halle, near Leipzig, where they were properly fed and accommodated until, two days later, 100 'Dakotas' arrived at the airfield to fly them to Brussels from where they were flown in 'Lancasters' to Oakley and thence by train to a tremendous reception at Cosford. Finally arriving at his home in Burntisland, Albert met a neighbour who told him "They are not expecting you." He was too polite to say other than "I'm sorry about that but I'm not going back!"

Flight Lieutenant Perring RAF VR(T) has now officially accepted the role of Commanding Officer of 296 (Stoke Newington) Sqn ATC.


Flight Lieutenant Perring has taught Cadets their First Class syllabus and filled the

We attended the parade at Bermondsey War Memorial at 11am with




our newly blessed Squadron Banner. Then we made our way to Stoke Newington Town Hall for another two minutes'
