



# COVER STORY Recording the Lives of the Allied Aircrew of the Battle of Britain

The Battle of Britain Memorial Trust's Database of the Few was launched in 2022. It contains biographical details of every Allied airman, from a wide variety of countries, known to have qualified for the "immediate" award of the 1939 – 1945 Star with Battle of Britain Clasp. The majority of almost 3,000 entries are accompanied by photographs of the men concerned.

Kenneth G Wynn (1925 – 2020) provided the basis of the database through his research, together with collaborators, for his book *Men of the Battle of Britain*. This was first published in 1989 and now runs to three editions and two supplementary volumes. In 2010 all the rights to the book, and Ken Wynn's material for it, were acquired from the author and the then publisher and donated anonymously to the Memorial Trust.

Since then, I have co-ordinated the contributions of a team of researchers as we work to keep expanding the information held on the Few. We now take more and more interest, not just in their flying careers, but their family backgrounds, education, civilian occupations and relatives who also served their countries. In this way we hope that the work is of interest to social, as well as military historians. Sometimes, in writing and re-writing entries, I find myself travelling down interesting, if not strictly relevant, byways. At least three pilots have a connection to the James Bond stories written by Ian Fleming. Indeed, Squadron Leader (in 1940) Harry Eeles was related to James Bond. He was a stepbrother of the ornithologist of that name who produced a standard work on the birds of the West Indies. Fleming had a copy of the book and, looking for an ordinary name for his hero, borrowed "James Bond" from his bookshelves.



Some of the Few moved in artistic circles. Pilot Officer James Buchanan (pictured left) was killed in action on 27 July 1940 in a Spitfire of No 609 Squadron. His family home in Sussex was, between the wars, the hub of a creative community which, for a time, included Paul Nash whose painting, *Battle of Britain* (1941) is often reproduced. Squadron Leader Hamish West's father was the Scottish watercolourist, David West.

Lieutenant Hugh Joseph "Huseph" Riddle, whose career as an artist included a commission to paint the Late Queen Elizabeth II for the RAF Regiment in 1965.



The social backgrounds of the Few are more varied than is sometimes supposed. One of the earliest Spitfire aces was Flight Sergeant Bill Franklin (pictured left) of No 65 Squadron. He was born in Poplar in 1911 and attended Thomas Street Central School in Limehouse.

His father was a general labourer who was killed with the King's Royal Rifle Corps in the Great War. Bill Franklin was commissioned before the end of the Battle of Britain and was lost in action on 12 December 1940.



Chronicled too are the efforts of many of the Polish and Czechoslovak aircrew to reach England, often via service with French forces. Among them was Pilot Officer Jaroslav Sterbacek (pictured left) who had escaped from Czechoslovakia to France and then to Britain.

His first day of fighting with No 310 Squadron was 31 August 1940 and his Hurricane did not return to Duxford from an engagement over the Thames Estuary. His remains were never found and he is commemorated at Runnymede.

However, unusually, somebody has funded a CWGC-style gravestone, appropriate to his nationality, with his name on at Brookwood cemetery in Surrey.



There seems little doubt that the middle name of Pilot Officer Richard Chester Lawson (pictured left), a Hurricane pilot with No 601 Squadron, reflected a point in the career of his father.

In 1916 Captain (later Rear Admiral) Robert Lawson commanded the new light cruiser, HMS *Chester*, at the Battle of Jutland. The ship was badly hit and from the bridge Captain Lawson witnessed the mortally wounded 16-year-old Boy (First Class) John "Jack" Cornwell remaining at his post awaiting further orders. Captain

Lawson's report led to the award of a posthumous VC to Cornwell. Richard Lawson stayed with 601 Squadron. He was lost in February 1941 during a Roadstead, a low-level attack on coastal shipping.

The oldest man known to have qualified for the Battle of Britain Clasp was Pilot Officer Sydney Carlin, a veteran of the Royal Flying Corps in the First World War, who was 51 when he flew as a Defiant air gunner with No 264 Squadron.



The youngest pilot with a proven birth date was Pilot Officer (Martyn) Aurel King (pictured left) who was born in Essex on 15 October 1921. He was therefore not yet 19 on 16 August 1940 when he was forced to bale out over the outskirts of Southampton during the action for which Flight Lieutenant "Nick" Nicolson was awarded

the VC. Pilot Officer King's parachute collapsed on the way down, apparently damaged by enemy fire when his aircraft was attacked, and he died shortly after landing.

# 1941 Appeal Update

Thank you for your very kind and wonderful support of the 1941 Appeal launched in April 2022. In addition to the money raised by the Friends of St Clement Danes in 2021, a special mention needs to be made to all those Friends who kindly donated a further £1,030 in answer to the call of donating an “inch” towards the steeple restoration. Thank you all for your amazing donations.

It has been a challenging period, not least recovering from the Covid pandemic and additional external factors notwithstanding the cost-of-living crisis to navigate over and around.

However, we are delighted to report that in the first year of the appeal we have managed to raise over £50,000 – so whilst we do have a very long way to go significant progress is being made. When we achieve the 1941 Appeal donations target of £2 million for the repair of the steeple the work can then commence.



The steeple was inspected again in early February by a specialist team of steeplejacks, they climb the exterior of the steeple, looking for signs of further damage and degradation of the 1719 structure. We are now awaiting their report of the current condition and hope the cold winter has not caused further serious damage.



We have also started the work to develop the concept of the Crypt enlargement with our partners The Princes' Foundation. They have expert knowledge in the conservation and use of historic buildings throughout the UK and further afield. Although planning is in the early stages, the main aim is to develop a

wellbeing and community hub for veterans and local people.

## **3. Chairman's Opening Remarks**

The Acting Chairman welcomed those present to the AGM.

The Chairman had written a letter of condolence to the Friends Patron, HRH the Duke of Gloucester, following the death of Her late Majesty.

A reply had been received which was read out.

## **4. Election of Officers and Trustees**

The resolution was passed unanimously on a show of hands.

## **5. Minutes of Last Meeting**

The minutes of the last AGM had been made available via the Spring 2022 edition of O&L magazine and the Acting Chairman asked if there

were any questions. There being none, the minutes were accepted unanimously on a show of hands, Gavin Turnbull proposing and Scott Williamson seconding.

## **6. Treasurer's Report**

Copies of the Receipts and Payments Account for the year to 30 June 2022 were distributed (see page 25).

The Treasurer detailed the various sources of cash inflows and outflows. With £15,357 on the receipts side (including a £5,000 legacy) and £26,462 of expenditure, a deficit of £11,105 was reported for the year. As a result, the total cash balance of around £80,344 that existed 30 June 2021 had fallen to £69,238 on 30 June 2022.

The Treasurer explained that last year £11,777 of member donations to the Main Trust church tower repair appeal were included in last financial year's receipts figure. However, the Acting Chairman presented a cheque for £13,527 to the Main Trust, which was recorded in this financial year. As there were much lower church tower member donations this year, but last years were paid out, receipts this year dropped and expenditure rose.

The Treasurer explained that as receipts for the year were less than £25,000, a formal audit of the accounts was not required under Charity Commission rules. Approval of the accounts was proposed by C J Hill, seconded by Scott Williamson and passed unanimously on a show of hands.

## **7. Membership Secretary's Report**

The Membership Secretary reported that last year he thought membership numbers stood at 541. Currently we have 484 due to the loss principally of Life Members including, very sadly, the wife of the first ever Membership Secretary of the Friends. Annual subscription-paying member numbers are about the same.

In an effort to get a more accurate picture of actual member numbers, letters had been sent out to members as part of the distribution of the Spring and Autumn O&L magazines, asking members to confirm their

details. 60% replied overall (74% of annual subscription payers and 48% of life members). He also appealed to those present to be on the lookout for potential new members and ask them to join the Friends. The Trustees recommended keeping subscription fees at their current level for the time being. This will be reviewed in advance of the next AGM.

### **8. Any Other Business**

The Treasurer explained the Trustees had reviewed the methodology for calculating the cash reserve set aside to cover reimbursements in the event that the Friends should cease to operate. From 2013 to date, the calculation assumed an 80-year life span for members, with the reserve declining every year to zero at the point that milestone was achieved. Under that calculation methodology, around £40,000 would be held in reserve overall, roughly the equivalent of the balance held in the Friends' Unity Bank account. However, given that the one-off up-front life membership subscription, when it was available, was roughly the equivalent of 18 regular annual subscriptions, and assuming Friends would feel they had received full value for their subscription after 18 years had passed and not expect a refund thereafter, if the reserve is calculated by amortising the life membership fee across 18 years for each individual life membership, the overall reserve for all life memberships would total £12,290. In other words, around £30,000 of reserves would be freed up. The reserve would also decline to zero in about ten years from now.

The Trustees recommended that this new calculation methodology be adopted. Approval of the new reserve calculation methodology was proposed by the Acting Chairman, seconded by Peter Neville Lewis and passed unanimously on a show of hands.

# **Financial Report for the AGM Accounting Year Ending 30 June 2022**

The CC16A, which records the income and expenditure categories on which we report to the Charity Commission at the end of the year, is shown on the accompanying two pages. The figures are rounded up or down to the nearest whole pound in accordance with Charity Commission guidelines. Explanations of key areas are given in the paragraphs below.

All of what happened during the year was affected by the pandemic which impacted on just about everything and everyone during the accounting year. However, it is encouraging to see that things are improving.

Our total income was £15,357 (£22,887 last year). Last year our income was unusually high because of the success of the Spire Appeal – so this year income is at a more normal level.

Our income was made up of subscriptions, donations, Gift Aid claims and bank interest. Subscriptions were £6,387 (£6,105 last year). Our Membership Secretary's efforts are having a positive effect on our income. Total donations and legacies for the year were £6,434 (£2,136 last year). 2021-22 saw the return of the Concert and that generated £1,410 of ticket revenue. Gift Aid claims added £888 to our balance and more repayment claims are in hand. Bank interest was a mere £3 (£7 last year). Finally, we received £55 from sales. Hopefully we will see this increase during the current year.

Expenditure for the year was £26,462 (£8,024 last year). A large part of that was due to our presentation of a cheque for £13,527 to the church at last year's concert for the Spire Appeal. Grants paid to the Church totalled £1,210 (£1,560 last year). We anticipate that this will increase in the current year. Payment for the issues of the Oranges & Lemons, including printing costs, postage and editor fees were slightly up at £6,075 (£5,465 last year). The Concert incurred costs of £3,395 which was a bit up on the costs of the 2019 Concert. There was, of course no 2020 concert. Bank charges for the running of the BACS system for membership direct debits and general charges were £778 (£709 last year).

Expenditure is completed by Trustee expenses and general support costs £1,007 compared to £29 in the previous year. The only positive thing about the pandemic was that it reduced some of our expenses!

At the end of the year we had a deficit amounting to £11,105 and we ended the year with our Bank Accounts holding £69,238 (£80,344 last year). Much of that deficit is, of course from the Spire Appeal donation which was paid to the main Church Charity. To put that in perspective the balances on 30 June 2020 were £65,481, so we are still a bit better off than we were then. In accordance with Charity Commission Regulations as our income is below £25,000 we do not require an audit or Independent Examination.

Your Trustees are content that the information presented herein is a true and accurate statement of the financial affairs of the Friends of St Clement Danes.



# A Tribute to 551369 Flight Sergeant Arthur 'Stokey' Stokes, DFM

Arthur was born to Jennie Louisa Stokes on Thursday 18 November 1920, at 182 Grove Street, Liverpool. He enlisted in the Royal Air Force on Tuesday 19 January 1937, aged 16 years and 3 months.

He was decorated with the Distinguished Flying Medal (DFM) by His Majesty King George VI on Friday 26 September 1941. (Arthur is pictured below, second from left.)



His medal came with the words: 'This N.C.O. has completed 40 operational flights as First Wireless Operator. He joined the Squadron on 13 September 1939, and was posted on the 14 November 1940. He has consistently displayed exceptional keenness and technical ability of the highest order. His enthusiasm

and capacity for operational work has been an inspiration and example to all other Wireless Operators. He is an invaluable asset to the squadron'.

The award of the DFM was published in The London Gazette dated 17 January 1941.

Starting with 51 Squadron, Arthur then served with 'B' Flight 102 Squadron at RAF Driffield (East Yorkshire) and then RAF Leeming (North Yorkshire) from 11 September 1939 until 5 November 1940. His first operational sortie was on 26 February 1940 to bomb Cologne, with Pilot McArthur in command of the aircraft.

During his service with 102 Squadron, Arthur flew with the then Pilot Officer (Leonard) Cheshire, who described him as "the best wireless operator in the Squadron" in his biography 'No Passing Glory', (pages 104 & 105).

Whilst with 102 Squadron Arthur survived the bombing of RAF Driffield on the 15 August 1940. Arthur is quoted in a book from the time stating 'At about 1:30pm, my roommate in the Sergeant's Mess looked out of the window and said, 'What are all these Blenheim's flying about for?' (He was later given extra instruction on aircraft recognition!). Then the bombs started exploding. I left my bed in a hurry - I'd been on the Milan raid and was having a 'lie in'. Our room was on the first-floor hut but without hesitation I leapt through the window landing on the grass below. I then 'streaked' across the grass and flung myself into the shelter.' Inside the shelter he discovered he'd literally 'streaked' across the grass - he was only wearing his shirt!

One of his operations was the famous Operation Gunnerside, the dropping of saboteurs to destroy the Norsk Hydro heavy water plant (crucial for the German atomic bomb project) at Vemork in German-occupied Norway.

On completion of his time with 102 Squadron he was then presented with an opportunity to become an instructor. However, Arthur declined this offer as he wanted to remain operational. He then had the honour of joining 138 (Special Duties) Squadron, RAF Tempsford, Bedfordshire.



Arthur was killed in action on Sunday 14 March 1943 when, on Operation Bronze to Czechoslovakia to drop two Czech spies into an enemy occupied country, Halifax BB281, NF-O crashed in Munich, Germany.

Arthur lies at rest with his crew in Durnbach War Cemetery, Bad Tolz, Germany (pictured left).

# St Clement Danes Lodge

St Clement Danes Freemasons Lodge was formed on 4 May 1871 as a Parish Lodge, by petition to the Grand Lodge of England, supported by the two Church Wardens of the Church and was to consist of up to 12 members who lived in the

Parish. The link with the Church continued as in 1914 when it was proposed that Revd William Pennington, who was Rector of St Clement Danes Church be a candidate for freemasonry on 5 March 1914 becoming a Master Mason in the December, by which time he is recorded as the Chaplain of the Lodge.

Our 150<sup>th</sup> anniversary fell in 2021, but due to the prevalent Covid-19 restriction our plans were postponed until Saturday 21 May 2022. The Lodge members, their wives/partners and children (some 30+ of us) met in Room 9 Great Queens Street which was the same room number of the first meeting of the Lodge! However, the building has been rebuilt since those early days.



Our guests received a reprise of our history, which many of you will have read in earlier O&Ls, but here it is noteworthy to point out the rare nature of St Clement Danes Lodge. Not only is it one of the last parish Lodges still in existence, but the United Grand Lodge at Great Queens Street (pictured left) is in the St Clement Danes parish and as such The Lodge subscribed 10 guineas per member to the rebuilding of Great Queens Street after it was destroyed in the Great War. Subsequently it has been known as a Hall Sone Lodge.

Following the presentations in Room 9, it being a nice day, we strolled through the parish the short distance to our Church where Di Bentley regaled us with an entertaining oversight into the parish history. It stretched from its early routes and the first wooden tabernacle which was used on the site by the Danes, up to its destruction in WW2. This was followed by the public subscription to rebuild the Wren Church with the Gibb tower to become the Central Church of the RAF. The Lodge also subscribed to the rebuilding of the Church.


